- The candidate should bring FC/SC acknowledgement receipt/ Provisional allotment letter with college admission receipt/Bonafide certificate in case the candidate has already taken admission in other college.
- The candidate should bring all original documents for the admission process. If a candidate is unable to produce original certificates at the time of his/her admission on account of admission already secured in other institute, he/she shall produce the **Original Bonafide Certificate/College Admission Receipt and Xerox copies of all such documents attested by head/principal** of the concerned institute. Such candidates shall be required to pay the fees

(Candidate with Bonafide certificate, has to pay requisite fees) immediately at the time of admission and such candidate shall be permitted to submit the required original documents **on or before 28th Dec 2021 (3.00pm)** otherwise his/her admission will stand automatically cancelled and fees paid shall be forfeited.

- The candidate have to pay prescribed fees Rs. **17385/-** for B. Pharm, **16843/-** for Direct Second Year B. Pharm and Rs. **36223/-** for M. Pharm respectively immediately at the time of admission.
